## Making Estimated Tax Payments to the CA Franchise Tax Board

- Open the following address in your browser: <https://www.ftb.ca.gov/pay/>
- Under the section labeled 'Make a payment', select 'Bank account'.
- Under the section labeled 'Personal', select 'Use Web Pay personal'
- Enter your Social Security Number (no spaces), Last Name, the captcha, and click 'Login'.
- Enter Name and Address and click 'Continue'.
- Select 'Estimated Tax Payment (Form 540-ES)' and click 'Continue'.
- Select the tax year for which you are making an estimated payment.
- Select 'Add an estimated tax payment', add 'Payment Amount', 'Payment Date', and click 'Continue'.
- Repeat prior step for all payments scheduled.
- Select appropriate response to 'Joint tax payment', respond 'Yes' or 'No', and click 'Continue'.
- If 'Yes' to 'Joint tax payment', enter spouse's name and address, and click 'Continue'.
- Enter your payment information and bank account information and click 'Next'.
- Review the payment, enter you email and phone number and click 'Submit'.  
We strongly recommend you save a copy of the confirmation page for your records.
